

JULY 2, 2018 REGULAR MEETING MINUTES

CALL TO ORDER: Supervisor James Soli called the Regular Board meeting to order at 6:00 P.M. at the Arvon Township fire hall on July 2, 2018.

ROLL CALL OF MEMBERS PRESENT: James Soli-Supervisor, Krystal Larson-Treasurer, Lisa Marinich-Clerk, Karl Gipp-Trustee, Keith Erickson-Trustee.

MINUTES APPROVAL: Erickson motioned, seconded by Gipp to approve the June 4, 2018 minutes. All in favor, motion passed.

AGENDA APPROVAL: Soli requests "Building Inspections" under "New Business". With the addition, Gipp motioned, seconded by Erickson to approve the agenda. All in favor, motion passed.

PUBLIC COMMENT: Kelly Erickson let the board know that the Park outhouse needs to be pumped. Kelly will call Stiglich.

OLD BUSINESS: Soli would like to see the Skanee Cemetery, Witz Road property and the township property on Pt. Abbaye surveyed. Will have to put an ad in the paper.

-There were no bids for the office in the fire hall and the side entrances on the new fire hall. Marinich will put an ad in the paper again. Deadline to be August 5, 2018.

-The Township received the first payment from LongYear for the amount of \$14,303.23. Soli would like to see some of this money go towards the surveying that needs to get done.

NEW BUSINESS: Soli let the board know that if a person is within 500 feet of either lake or river frontage, they have to apply for a soil erosion permit. Soli would like Ken Anderson to update the township website with this information when building on the water.

-Ken Anderson explained that the Townships building inspections have been set at \$35.00 per inspection for years. Would like to see it raise to \$50.00 per inspection. Erickson motioned, seconded by Gipp to approve the increase. All in favor, motion passed.

JAMES FEDIE: Fedie has been doing field work, the taxes went out July 2nd. The Board of Review will be meeting July 17th at 9:00 A.M.

PUBLIC COMMENT: Harold Ripple would like to see a speed limit sign on the Town Rd. Soli will talk to Doug Mills about it.

-Erickson said that there will be girl's baseball tournaments in August at the Skanee ball field.

-Leslie Elmblad went to the L'Anse Twp and village to get a copy of their cemetery ordinance. Leslie will get a hold of Jim Nankervis for help with setting up an ordinance for Arvon Township.

MAIL CALL: Tikky's Tree Service gave a bid for the tree removal. Taking down 5 maples nearest to town hall, chip brush, leave wood-\$2,975.00, to take the wood away-\$2,475.00. Gipp motioned, seconded by Erickson to hire Tikky's for the job. All in favor, motion passed.

TREASURER'S REPORT: The Treasurer's Report was the same as last month, General Fund-\$184,856.32 Ambulance/EMT Fund-\$27,073.22 Fire Fund-\$100,351.51 Liquor Fund-\$307.46, Road Fund-\$16,884.15. Erickson motioned, seconded by Gipp to approve the Treasurer's Report. All in favor, motion passed.

BILL APPROVAL: Except for paying the Bianco bill, Erickson motioned, seconded by Larson to approve the bills. All in favor, motion passed.

NEXT MEETING DATE: The next meeting date will be August 6, 2018 at 6:00 P.M. at the Fire hall.

ADJOURN: Gipp motioned, seconded by Erickson to adjourn at 6:25 P.M. All in favor, motion passed.
