NEW BUSINESS: U.P. Engineers received seven bids on the Skanee Park project. MD Contracting was the low bidder at \$47,643.00 and has been determined by the Engineer to be qualified, furthermore recommends the contract award to the low bidder, MD Contracting. Resolution NO. 1 states that the Arvon Twp Board hereby awards the contract to MD Contracting in the amount of \$47,643.00, upon final approval by MDNR. Gipp motioned, seconded by Erickson to approve the Resolution on June 6, 2016. All in favor, resolution passed. The contractor would be starting the project sometime mid-July and expects approximately 2 weeks of work.

-Jerry Hollon asked the board for at least 2 loads of gravel for the cemetery. Gipp motioned, seconded by Erickson to approve the gravel. All in favor, motion passed.

<u>JAMES FEDIE:</u> Fedie sent Drue an email letting the board know that he has been out in the field getting pictures and sketches on the properties in the township. He also attended the training on our mapping with BS & A. The sales mapping has not been completed as of yet. He should have everything ready to go and will give an update and overview of what it will look like on our computer at the July meeting.
