Longyear will not mark anything until Soli is present. Erickson motioned, seconded by Marinich to approve the logging the 38 acres. All in favor, motion passed.
- -Mike Roberts wanted to thank the board for the donation to the fire hall and town hall. Also the Aura Hall auxiliary wants to have a raffle, but need a governmental unit to back it up. Marinich motioned, seconded by Gipp to approve the application through the State of Michigan. All in favor, motion passed.
- -Erickson let the board know that the Kallio Fund in pretty large. He will meet with Leslie Elmblad to see what the Fund will donate this year.
