

ARVON TOWNSHIP REGULAR MEETING MINUTES

JUNE 1, 2026 DRAFT

CALL TO ORDER: Supervisor Jay Fish called the Regular Board meeting to order at 6:00 P.M. at the Arvon Township Fire Hall on June 1, 2026.

ROLL CALL OF MEMBERS PRESENT: Jay Fish-Supervisor, Lisa Marinich-Clerk, Krystal Eliason-Treasurer, Robert Janda-Trustee, Keith Erickson-Trustee/Absent.

MINUTES APPROVAL: It was brought to the board's attention that last month's meeting adjournment was off by an hour. Pat Janik informed the board that her name was misspelled and that she never informed the board the name of the firm but an attorney that works for the said firm. With the three changes, Janda motioned, seconded by Eliason to approve May 4, 2026 minutes. All in favor, motion passed.

AGENDA APPROVAL: Fish requested "Kallio Fund" under "New Business" and Nancy Strohshein requested "Planning Commission update" under "Old Business". Eliason motioned, seconded by Janda to approve the agenda with the two additions. All in favor, motion passed.

PUBLIC COMMENT: Several comments were made about the Vick's Road issue.

OLD BUSINESS: Strohshein let the board know that the updated Fee Schedule has been put on the township website.

-Fish let the board know that Jurmu Engineering charges \$140.00 an hour but for the township he would cap the cost of his fees at \$750.00 unless a more detailed report is required. Elison motioned seconded by Janda to hire Jurmu Engineering. All in favor, motion passed.

-Fish talked with the attorney that represents L'Anse Township and would represent Arvon Township at the same fee rate as L'Anse Township which is \$285.00 per hour instead of \$500.00 per hour. With Erickson's absence from the meeting, this will be tabled.

NEW BUSINESS: Marinich requests approval for the August 4, 2026 election workers. Gail Hollon, Tammy Hollon and Debbie Vizina for election inspectors and Jenny Janda for the election Chairperson. Janda motioned, seconded by Fish to approve the workers. All in favor, motion passed.

TREASURERS REPORT: Eliason gave the monthly Treasurer's Report. General Fund-\$331,964.40, Ambulance/EMT Fund-\$57,741.91, Fire Fund-\$497,623.25, Liquor Fund-\$760.95, Road Fund-\$102,844.06. Marinich motioned, seconded by Janda, to approve the Treasurer's Report. All in favor, motion passed.

BILL APPROVAL: Janda motioned, seconded by Marinich to approve the bills. All in favor, motion passed.
