

## ARVON TOWNSHIP REGULAR MEETING MINUTES

SEPTEMBER 1, 2020

With the Covid-19 regulations, the September 1, 2020 regular meeting was held outside of the Skanee Fire Hall due to the attendance that showed up.

CALL TO ORDER: Supervisor James Soli called the Regular Board meeting to order at 6:00 P.M. at the Arvon Township Fire Hall on September 1, 2020.

ROLL CALL OF MEMBERS PRESENT: James Soli-Supervisor, Krystal Larson-Treasurer, Lisa Marinich-Clerk, Keith Erickson-Trustee, Chris Wahmhoff-Trustee.

MINUTES APPROVAL: Erickson motioned, seconded by Wahmhoff to approve August 3, 2020 minutes. All in favor, motion passed.

AGENDA APPROVAL: Soli requests "Tire Pickup" under "New Business" and Erickson requests "Porta Potty" under "Old Business". With the two additions, Erickson motioned, seconded by Larson to approve the agenda. All in favor, motion passed.

PUBLIC COMMENT: Marinich let the board know that the Kallio Fund donated \$1,500.00 towards the Skanee Cemetery clean up and \$700.00 towards the topsoil at the cemetery. The board thanked them for the donation.

After discussion, Erickson motioned, seconded by Marinich to approve the amendments and definitions to the ordinance. Larson also approve the amendments and definitions, Wahmhoff and Soli did not approve the amendments and definitions to the ordinance. Three in favor, motion was passed.
